### WHY adjust graduation requirements?

- By 2020, three out of every four jobs will require education beyond high school
- The State of Colorado recently adopted:
  - new academic *standards* which provide clear, high expectations for what students should know and be able to do at every grade level, and
  - new graduation requirements for the class of 2021

### The Primary Change

- New graduation requirements require students to demonstrate proficiency in English and math, subjects that reflect Colorado standards and 21st century skills
- Local Board/District graduation requirements may include additional elements, but must contain demonstration in English and math

### **Current Graduation Requirements**

BVSD currently requires students to acquire **220 credits to graduate** from a Boulder Valley high school.

These include:
40 in Language Arts
20 in Mathematics
20 in Physical Ed/Health
5 Practical
Money Management Course

30 in Social Studies
20 in Science
10 World Languages
5 Fine Arts
70 Electives



### **CDE Menu of Options**

• Options provided to districts include:

- Testing Options
- A District Capstone
- Industry Certificates
- Concurrent Enrollment
- The full Menu of Options can be found at <u>cde.state.co.us</u> and each district may adopt one, some, or all of the available options
- Districts can accommodate for specific students who will still earn a standard high school diploma
  - English learners
  - Gifted students
  - Students with disabilities

### **Testing Options: Career Readiness**

The Armed Services Vocational Aptitude Battery (ASVAB)

 A comprehensive test that helps determine students' eligibility and suitability for careers in the military.

#### **ACT WorkKeys**

 An assessment of students' job skills in applied reading, writing, mathematics and 21st century skills.
 Scores are based on job profiles that help employers select, hire, train, develop and retain a high-performance workforce.

### **Testing Options: Curricular Connections**

These tests are generally taken spring of the senior year, scores are received in June, after graduation which make them **problematic** as a graduation tool.

### **Advanced Placement (AP)**

- AP exams test students' ability to perform at a college level
- AP exam performance can earn college credit
- Associated with AP curriculum offered at most BVSD high schools

### International Baccalaureate (IB)

- IB exams assess students enrolled in the official IB Diploma Programme
- IB exam performance can earn college credit
- Associated with IB curriculum offered at Fairview and Centaurus High Schools

### **Testing Options: Standardized Exams**

ACT

• The nationally administered, standardized paper-and-pencil test that helps colleges evaluate candidates. The ACT was Colorado's standardized assessment until January 2016.

#### SAT

 SAT is a nationally administered, standardized paper-and-pencil test that helps colleges evaluate candidates. The SAT was endorsed as the state assessment by CDE in January 2016.

### Testing Options: Eliminated by BVSD

#### Accuplacer

 Most commonly used by Community Colleges to determine placement in courses. In Colorado, exam will be discontinued in September 2016. It is not yet clear if CDE will allow the replacement exam Community College Placement Test (CCPT) will be added as an option. We are not currently investing time in this option.

#### **ACT Compass**

 ACT will no longer be providing this exam as of November 2016. They report they do not plan to provide another version. BVSD is not considering this exam.

### **Testing Options: Preliminary Recommendation**

SAT be used as the primary testing option

- Aligns with current testing requirements
- Will continue to be provided free to all BVSD students during the spring of junior year
- This provides time to adjust the demonstration avenue prior to graduation as needed
  - re-take exam
  - take another exam
  - pursue other demonstration options

#### Accept ASVAB, ACT Works, ACT, IB or AP tests

- Test fees paid for at the family's expense
- Results presented to BVSD would be accepted

### Capstone: Experiment, Research, or Event







- Opportunity for life experience-based education and demonstration of skill mastery
  - Creative and personally meaningful avenue to pursue education and skill mastery
- Currently offered at some BVSD high schools.
  - Would be an expanded option for all district schools to uniformly implement
  - Required class during junior and/or senior year
- Alternative to testing-based demonstration of skill mastery

### Capstone: Portfolio Defense, Service Learning







- Opportunity for life experience-based education and demonstration of skill mastery
  - Creative and personally meaningful avenue to pursue education
- Currently offered at some BVSD high schools
  - Would be an expanded option for all district schools to uniformly implement
  - End of junior year review, provides time for revisions
- Alternative to testing-based demonstration of skill mastery

### **Capstone Options: Preliminary Recommendation**





• Aligns with current practice within BVSD



- Aligns with current practice of high school counselors
- Consider including elements of the Individual Career and Academic Plan (ICAP)
- Consider portfolio for math and science only
- Consider requiring for all 10th and 11th grade students
